Most uterine fibroids removed
Dr Ravindra Keshavrao Shelmohkar removed 63 uterine fibroids from a 34-year-old female patient in an open abdominal myomectomy conducted on 14 April 2021 from 9:45 a.m. to 10:45 a.m. at Pune District Education Association's Ayurved Ragnalaya and Sterling Multispeciality Hospital in Nugal, Pune, Maharashtra.

Surgery on the heaviest woman
Forty-two-year-old Amita Rajani, weighing 300 kg, underwent bariatric surgery performed by Dr Shashank Shah at his hospital in Pune, Maharashtra, in 2015. She was bedridden for eight years before the surgery and had multiple risk factors. She lost 214 kg as a result of the surgery.

Surgery on the world's heaviest teenager
Mihir Jain, then 14 years old, became the world's heaviest teenager to undergo bariatric surgery. He weighed 237 kg at the time, with a BMI of 92 kg/m². The surgery was performed by Dr Pradeep Kumar Chowbey at Max Hospital, Saket, New Delhi, and a team of six doctors in 2 hrs 20 mins in July 2018.

Highest spectacle power corrected surgically
The highest spectacle power of -32.5 D was corrected surgically by Dr Rahul Chaudhary on 22 March 2021 at Eye7 Eye Hospital, Lajpat Nagar, New Delhi. Myopia of right eye -25.00 diopter and -32.50 diopter of left eye in a 24-year-old female patient was

First home-grown anti-cancer CAR-T cell therapy
In April 2024, the President launched India's first home-grown anti-Cancer CAR-T cell therapy in Mumbai for cancer treatment, developed by IIT Bombay, Tata Memorial Centre and ImmunoACT. It is not only a first for India, but also deemed as the most affordable CAR-T therapy.
