1. On the day of interview candidates will be required to be present "in person" along with a signed hard copy of application and all required valid ORIGINAL documents (like Identity proof, age proof, degree(s), mark-sheets council registration documents, degree and experience etc. & one set of self-attested copy of these documents. You have to also bring original experience certificate clearly mentioning the duration of experience establishing that you have completed requisite years of teaching/ research experience (recognized by MCI/GOI) as per the advertisement. No extension of time on the day of interview will be given to you for this purpose.
2. The candidates will be required to bring a notarised affidavit on Rs. 10 (Non-Judicial) stamp paper as per **Annexure- A** at the time of interview. You have to also bring the attached filled form as **Annexure-B**.
3. No TA/DA will be paid for appearing in the interview. Those who are in employment must submit a "NO OBJECTION CERTIFICATE" from the employers at the time of Interview.
4. Candidates applying under any of the reserved category viz. SC/ST/OBC/PWD/EWS will be considered subject to submission of Caste/PWD/EWS Certificate on a prescribed format issued by the competent authority recognized by Govt. of India. OBC candidates should not belong to Creamy Layer and should be issued within validity period as per GOI instruction. Their sub-caste should be tallied with the Central List of OBC (non-creamy Layer) failing which their candidature will not be considered under the applied reserved category and will be treated as UR/Gen. Category.
