
Leave of absence was granted to Dr Sanjay Jaiswal, Prof. Randeep Guleria and Prof. Anil Kumar Bhowmik.



Thereafter, the Chairman, SAC requested the Member Secretary to introduce the agenda and initiate discussion for deliberations on the agenda items.

Action Taken Report on the Third Meeting of the Standing Academic Committee


Action Taken Report on the Minutes of the Third Standing Academic Committee was deliberated upon. Regarding **Agenda No. 1** (Confirmation of the attached minutes of the Second meeting of the Standing Committee), it was decided that the meeting of the Standing Academic Committee, as decided earlier, should be held atleast once in 3 months to update the members the activities of the Institution.


Regarding strong objections by the Chairman to the advertisement issued in April, 2018, the observations were noted for further compliance.

Dr Jaiswal had a concern about wrong selection of faculty members. It was mentioned by him that Dr Vikas Arya Committee Report in this regard was not followed. To this, Director, AIIMS, Patna stated that one more High Powered Committee consisting of 4 members has been formed, which will submit a report on the implementation of the Vikas Arya Committee. The Government has directed that the Institute Body should take action as per the recommendations of the High Powered Committee. The matter was also discussed in the last meeting of the Institute Body. It was pointed that we must seek the legal opinion in the matter. The Institute has since sought the legal opinion in the matter. All the members present agreed that the Standing Committee has been apprised of the matter being pending the Institute Body and it is believed that henceforth, the matter will not come under the domain of the Standing Academic Committee.

Regarding **starting of the PG Courses in different specialities**, it was informed by the Director, AIIMS, Patna that of the 78 seats approved, 46 have already been filled in January session and the remaining seats would be available for being filled in the next academic session. The same has also been approved by the Institute Body. Regarding **start of Ph. D. program**, it was informed that the same has not yet started. The Chairman mentioned that if possible, the new advertisement should include the availability of seats for Ph.D programs from July session.

Regarding proposal for creation of infrastructural facilities, detailed requirement should be brought to the notice of the Standing Academic Committee for academic purposes as well as for patient care facilities. It was discussed that the minimum requirements of Medical Council of India should also be met in this regard.

Draft advertisement for Faculty Recruitment


The Director, AIIMS Patna, presented before the members of the SAC, the proposed new faculty advertisement. The members desired that the advertisement should be relooked at and should include the total posts sanctioned, filled posts, vacant positions, and the reservation roster. The advertisement should be reworked out at the earliest. It was felt that there should be a full fledged Department of Biostatistics with atleast one Professor and 4 other faculty members. There could be a Ph.D. program in Biostatistics as well.


The Director AIIMS Patna informed that the RRs for the posts in Endocrine surgery are as per SGPGI, Lucknow. For Trauma and Emergency, the RRs are same as per AIIMS, New Delhi. The pay scales and age limits are as per AIIMS, New Delhi. Other information and clauses in the proposed advertisement are also same as per AIIMS, New Delhi

Agenda point 4

Starting of PG Courses in different specialities

The seats proposed were discussed in detail by the members. The information related to various courses and the number of seats was provided by the Director, AIIMS, Patna. There were concerns that there are not adequate number of senior faculty members in various disciplines. The Director AIIMS Patna, informed that similar courses with similar faculty strength, in the absence of Professor and Additional Professor in a given Department, these courses have been started in other AIIMS. The members desired that attempts to fill all senior positions must be made in the right earnest at the earliest. In courses, where the Committee of Experts did not recommend any seat, the Standing Academic Committee discussed the need for such courses and agreed to sanction 2 seats per year, for each course, with the provision that attempts should be made to advertise faculty positions in these departments at the earliest.

Agenda point 6


Proposal for starting Para Medical courses

A proposal was placed for start of DM-Hepatology, M.Ch - Hepato-pancreato-biliary surgery and Liver Transplant, and, DM - Organ Transplant Anaesthesia and Critical


Activities of the Institute
